Therefore, we believe that further development of the farms specializing in fruit and vegetable industries should be based on the following principles: improvement of organizational and economic mechanisms of managing; strengthening and modernization of material and technical base; development of cooperatives and integration processes; diversification of markets; regulation of economic and foreign economic relations; development and implementation of effective and safe technologies; workers need to create social conditions.

At the present stage of the ongoing economic reforms, the rights of producers of fruit and vegetable and grape products are expanding their rights to use and dispose of their products, including export.

Nowadays, the demand for the actual volume of fruit and vegetable and grape products exported to other regions and countries is increasing. The output of fruit and vegetable and grape products can be forecasted, for example, by 20% for the near future and up to 30% for the long-term outlook. At the same time, it is possible to predict that most of the products exported abroad will be manufactured not by new fresh fruits, grapes and vegetables but by industrial processing products.

The demand for raw materials for processing is estimated taking into account the increase in the capacity of processing enterprises in the long term due to the growing demand for fruits and vegetables and grape products. At the same time, the demand for grape products is increasing as a raw material for wine, juice and raisin production, which is fully consistent with the trends of the world market.

The consumption of fruits and vegetables and grapes in the rural population is mostly natural, and is less noticeable than cash and market prices. Most of the rural population grows fruits, grapes and vegetables directly on their own land parcels.

Given the demand for fruits and vegetables and grape products in urban areas, its size will largely depend on the size of cash income of the population and the market price of the product. Given the complexity of land and water resources in the cities and districts of Fergana region, attention is paid to increasing productivity of fruit and vegetable and grape products on the basis of intensive production.
